Skatium Locker Room Renovation Responses to Bidder Questions and Written Identification of Modifications to Project Documents

Responses to Bidder Questions:

Questions in Black Answers in Red

1. Drawing AD-101 Note 9 indicates to remove stairs and railings. No stairs and railings are indicated to be removed. Please advise.

Correct. Note 9 was not used to define scope.

2. Please confirm the following insurance language can be modified/stricken from the contract requirements (Article 11 Insurance and Bonds): 11.1.4 – amend cancellation from 60 days to 30 days, which your policy currently provides. 11.3.1.2, iii and 11.3.1.6 – strike these sections for asbestos abatement. If you are performing this work, then please let us know as we may need to secure quotes for this exposure.

Section 11.1.4 will be amended from 60 to 30 days. Sections 11.3.1.2, iii and 11.3.1.6 will be stricken. No asbestos work is anticipated.

3. Enlarged floor plans on A-601 seem to indicate cubbies and hooks at locker rooms and changing rooms, however, A-701 elevations indicate cubbies and hooks only at the changing rooms and hooks ONLY at locker rooms. Please advise if cubbies AND hooks are to be provided at the locker rooms.

Both drawings are correct. Perpendicular lines on benches on A-601 indicate space for each skater.

4. Who is the Fire Alarm Vendor for this bid?

There is no fire alarm vendor for this bid. Bidders are invited to contact Unifire Incorporated, which performs work in the building for the Township. Contact is Rich Lechette, 610-259-5400. The existing system is a Honeywell Silent Knight.

5. Are the existing CMU penetrations for the existing wall EFs being re-used on the south side of the building?

Yes, per note D7 on Sheet M-101.

6. Details A10 and F15 on A-501 show bench steel brackets and support pedestals. Please advise if these are to be stainless steel.

Powder-coated, by any available manufacturer.

7. Is the roof under warranty?

The roof is not under warranty. The roof material is TPO and has been assessed to be in good condition.
